NOTES TO THE ACCOUNTS FOR THE YEAR ENDING 31 DECEMBER 2014

GENERAL

These accounts have been prepared on a cash basis
At balance date there were no outstanding amounts owed by or owing to the Federation

NOTES

1. Development Programme

Include the amount of \$7000.92 as referred to in last year's accounts as a Post Date Settlement

2. Asia/Pacific Tennis League

Includes all costs but no reimbursement of the Player Hotel Grant for both teams (\$4,200) plus prize money for the forthcoming event (minimum for 8th place \$3,000)

3. General Meeting and Executive Meeting

The Annual General Meeting was held on Sunday 13th April at Vuda Point, Lautoka, Fiji and the Executive Meeting the day before on Saturday 12th April also at Vuda Point, Lautoka, Fiji. Included in these accounts also are all the accommodation, travel and related costs for the 2015 AGM on the 25th January in Melbourne. Income to partially fund the meetings is received annually as part of the ITF Regional Grant. The 2014 Budget allocated funds for accommodation, travel and general meeting expenses for the 2014 GM

4. Fiji Sports Council

The Fiji Sports Council charges the OTF a lease fee of FJ\$16,000 (AU\$9916.42) for the RTC in Lautoka
